OFFER LETTER

Sub: Offer letter for appointment to the post of Assistant Professor in the Department of Chemistry of Rajiv Gandhi University.

With reference to his/her application for the post of Assistant Professor in Chemistry, subsequent interview and approval of the 10th Executive Council of the University, the Vice-Chancellor, Rajiv Gandhi University is pleased to offer Dr. Md. Harunar Rashid for the post of Assistant Professor in Chemistry in Rajiv Gandhi University in scale of pay Rs.15,600-39,100 + AGP 6000/- p.m. plus other allowances as admissible under rules from time to time. 6. Initially University will not be able to provide residential accommodation and as such he / she will have to manage own accommodation.

If Dr. Md. Harunar Rashid accepts the offer he/she should report for duty within 1 month from the issue of this Offer Letter, failing which it will be presumed that he/she is not interested in the offer and the same will stand cancelled.


