In partial modification of the Admission Notice dated 06.05.2026, the Rajiv Gandhi University invites applications for biannual admission to Doctor of Philosophy (Ph.D.) programmes for the July Cycle, 2026. The candidates may register and apply ONLINE mode through Samarth only and transmit the requisite fee @Rs. 300/- (Rupees Three Hundred) only as and when prompted in the system with relevant documents on or before **29.05.2026** for the courses by visiting the Live Online Samarth Portal of Rajiv Gandhi University.

The admission shall be done on the basis of Scores Obtained in the National Eligibility Test (NET). However, for those Ph.D. programmes which comes under certain regulatory body such as ICAR and in such departments that do not receive minimum of 5 (five) valid applications or which no relevant NET examination exists, shall have to apply for the Rajiv Gandhi University PH.D.
