THEME CONCEPT NOTE

Most countries on the globe, be it in the immediate neighbourhood; in the extended neighbourhood; or elsewhere which are democracy have been struggling on one or the other count to strengthen democratic processes and keep the sanctity of electoral democracy intact. Democracy is the only form of government which provides maximum of individual freedom, for which the mankind entered into state, and continues to be part of it. However, consolidating electoral democracy has never been without challenges. Consolidation of electoral democracies largely depend upon: the way politics has evolved or been evolving in any particular country; the way political system has been responding to the changing dynamics of social, political, cultural, and economic modernization in the country; the way voters are made increasingly responsible while exercising their right to franchise; and the way voters are registered on the electoral rolls of their country. There could be umpteen numbers of factors responsible for consolidation of democracy in any polity. Consolidation of democracy means that the democracy is becoming increasingly inclusive, sustainable, resilient and future oriented.

'Electoral Roll' (Voter Register) is the list in which eligible voters of the country are registered. It is necessary that every eligible voter must get himself/herself registered on the electoral roll; as well as exercise their franchise diligently, has emerged as one of the strongest instrumentalities of consolidation of electoral democracies, and way to make it increasingly inclusive and sustainable in future.

It is in this context that brainstorming is needed regarding "Voter Registration and Voter Registers",

i.e., preparation of electoral rolls to make it increasingly inclusive and ensure that the enrolled voters are exercising their right to franchise. 'Electoral Rolls' is thus, one of the major instruments of strengthening democracies and India being the mother of all democracies in the world needs to be extremely updated on the same. India is the largest democracy on planet earth, hence, preparation of electoral rolls and its periodical cleaning and updation are herculean task demanding gigantic task-oriented interventions by relevant institutions. This alone is in great fitness of democracy and strengthening of democratic processes.



Tentative Timeline for the Conference:

- 01 Abstract Submission: Last date April 30, 2026**

Interested participants are requested to submit an abstract of their Paper/Research that they intend to deliberate upon in the Conference by the given date. The abstract must not be more than 500 words.

- 02 Intimation of Accepted Abstract: May 17, 2026**

Participants shall be intimated through email about the acceptance of their abstract by the given date, subsequent to which they will have to prepare their full-length paper by the mentioned-date.

- 03 Submission of Full-Paper: July 24, 2026**

Participants who are intimated about the acceptance of their abstract will have to submit their full-paper latest by July 24, 2026. The Guidelines for the same has been provided separately under the head "Author's Guidelines".

- 04 Tentative Dates of the International Conference:**

September 2-3, 2026.

- 05 Venue of the Conference: Ranchi, Jharkhand**

Participants and Delegates shall be intimated about the exact location of the Venue and facilities, once their participation is confirmed and the Full-Paper is accepted.



The Conference intends to provide opportunities to develop a shared vision on global challenges being faced by Election Management Bodies and deliberate on model standards and best practices across the globe to address the challenges towards making 'Voter Registration' a smooth and easy process; and make the 'Voter Registers' (Electoral Rolls) inclusive, dynamic, accessible and meaningful. Thus, an inclusive voter registers is the road to inclusive democracy which would be sustainable and resilient. Hence, the organizers of the International Conference intend to produce a report after the Conference which would serve as reference and guidelines for policy-makers to this effect.

The proposed Conference would have number of other outcomes:

- It shall educate and enlighten the participating community in the International Conference, as well as other participants like academicians, practitioners, journalists and members of the civil-society.
- The brainstorming session would produce documents and reports which would be published in the form of edited volumes for the larger consumption of academic community and policy-makers.

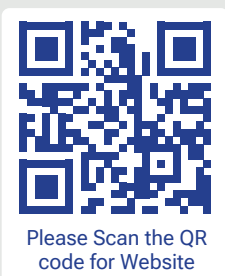
